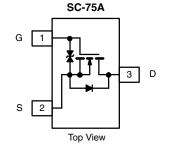

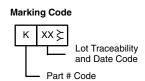

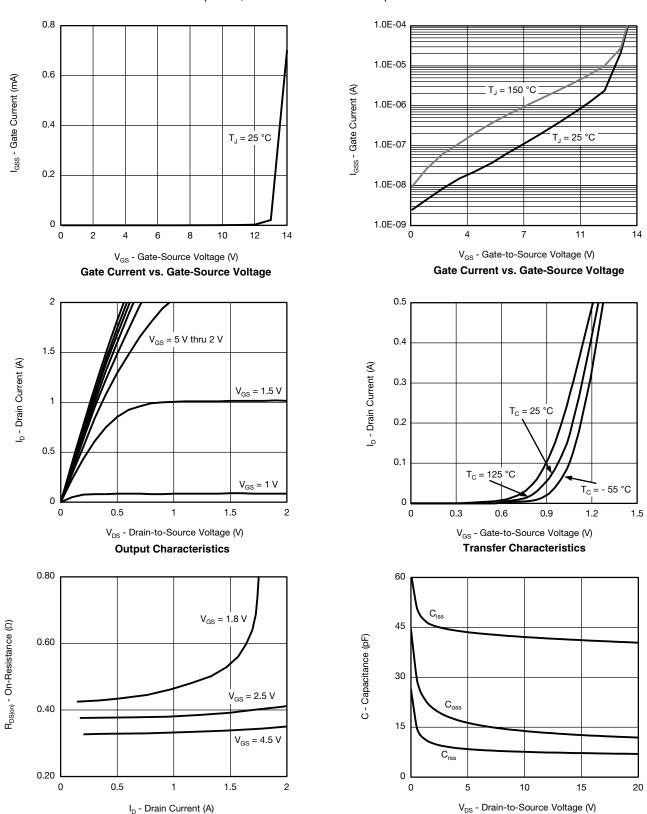

TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)



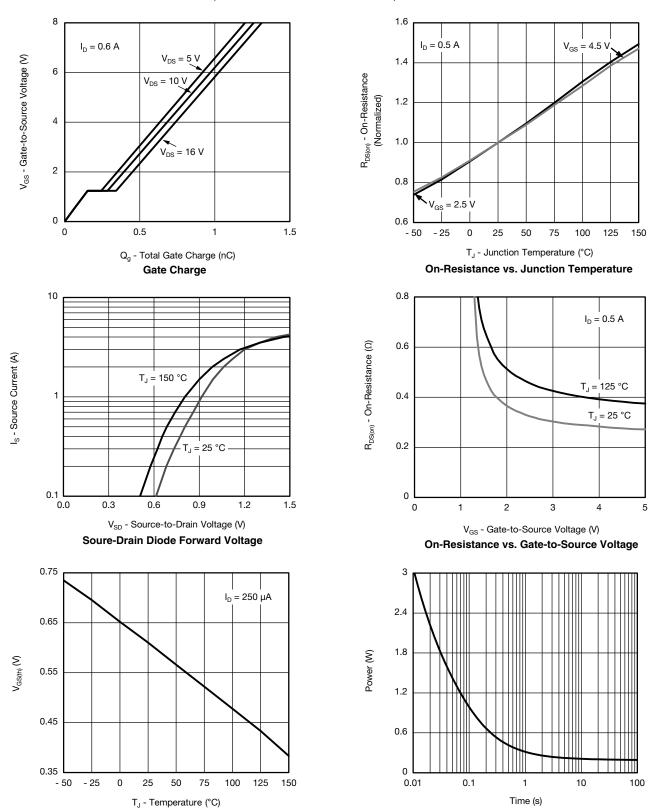
On-Resistance vs. Drain Current

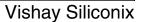

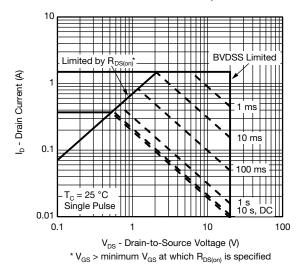
Threshold Voltage

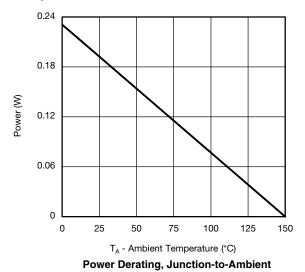
Single Pulse Power, Junction-to-Ambient





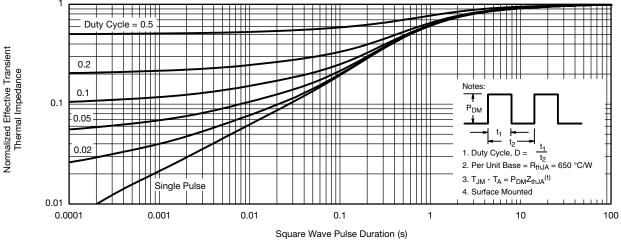

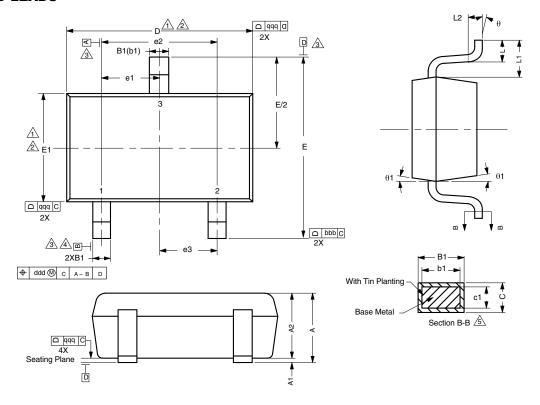


Normalized Thermal Transient Impedance, Junction-to-Ambient

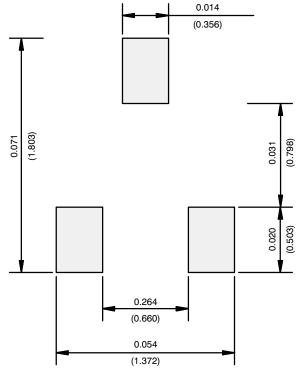
