Its flat window provides a wide aperture, making it ideal for use with external optics.


The diode is case compatible to the TEMT3700 phototransistor, allowing the user to assemble his own optical interrupters.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 4. Forward Current vs. Forward Voltage




Figure 5. Relative Forward Voltage vs. Ambient Temperature




Figure 6. Radiant Intensity vs. Forward Current




Figure 7. Radiant Power vs. Forward Current




Figure 8. Rel. Radiant Intensity\Power vs. Ambient Temperature




Figure 9. Relative Radiant Power vs. Wavelength






Figure 10. Relative Radiant Intensity vs. Angular Displacement

### **Ozone Depleting Substances Policy Statement**

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
