




Figure 1. Forward Voltage vs. Forward Current




Figure 2. Typical I<sub>C</sub> vs. V<sub>CE</sub>




Figure 3. Typical I<sub>C</sub> vs. V<sub>CE</sub> vs. Temperature





Figure 4. Typical NCTR vs. LED Current




Figure 6. Typical I<sub>CEO</sub> vs. Temperature




Figure 7. Low to High Propagation Delay vs. Collector Load Resistance and LED Current






Figure 8. High to low Propagation Delay vs. Collector Load Resistance and LED Current









