General Description

The CHV2710 internally pre-matched power HBT device provides 9 dB of gain, 2.5% EVM at 29 dBm output power for 802.16 OFDM signal with a peak to average power ratio of 9 dB. The device operates off a single supply voltage up to 12V and includes internal bias circuitry to enable exact setting of the quiescent current using an external Vcontrol. 


TOP VIEW

RECOMMENDED SOLDER PAD PITCH AND DIMENSIONS










