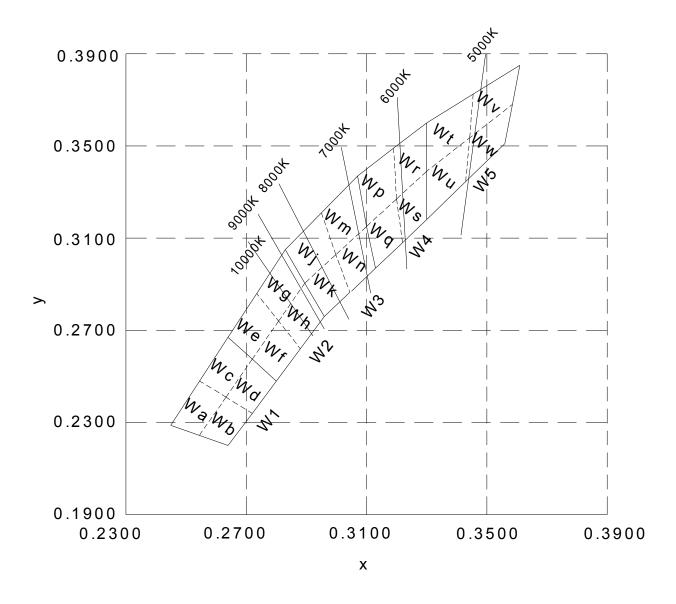

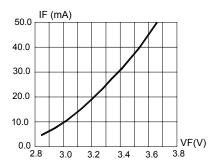


FIG.1 FORWARD CURRENT VS. FORWARD VOLTAGE.

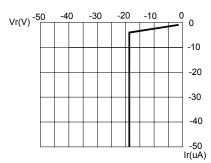


FIG.3 REVERSE CURRENT VS. REVERSE VOLTAGE.

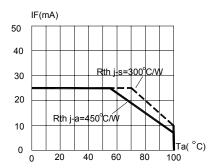


FIG.5 MAXIMUM FORWARD DCCURRENT VS AMBIENT TEMPERATURE (Tjmax=110  $^{\circ}\text{C})$ 

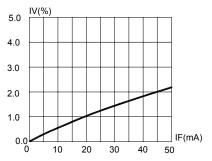


FIG.2 RELATIVE LUMINOUS INTENSITY VS. FORWARD CURRENT

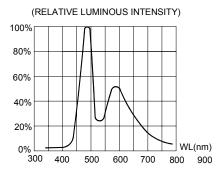


FIG.4 RELATIVE LUMINOUS INTENSITY VS. WAVELENGTH.

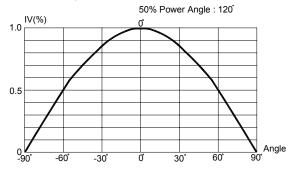
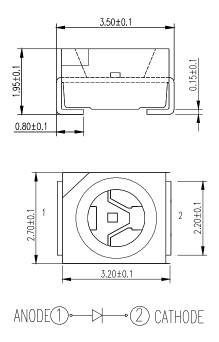


FIG.6 FAR FIELD PATTERN

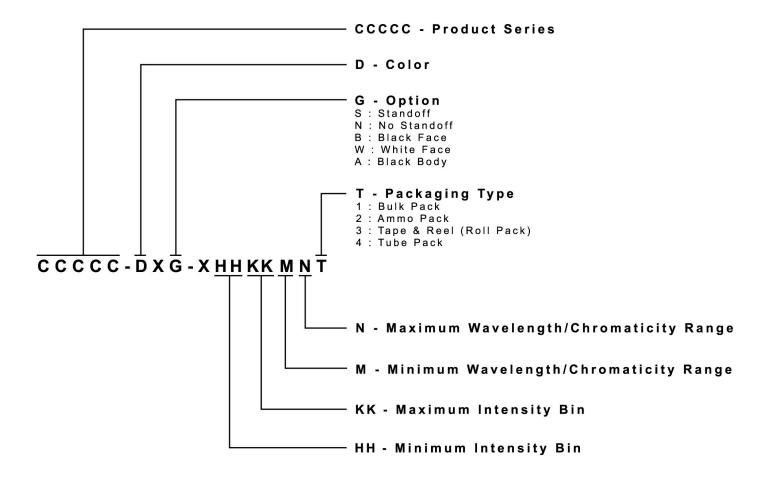

## **Packaging**

- The boxes are not water-resistant, and they must be kept away from water and moisture.
