






FIG.5 MAXIMUM FORWARD CURRENT VS. AMBIENT TEMPERATURE(T_Mox=105°C)





FIG.2 REVERSE CURRENT VS. REVERSE VOLTAGE







FIG.4 RELATIVE LUMINDUS INTENSITY VS. VAVELENGH




Mechanical Dimensions


