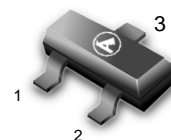

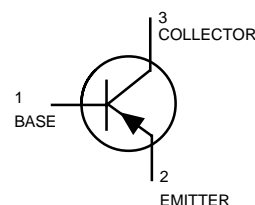

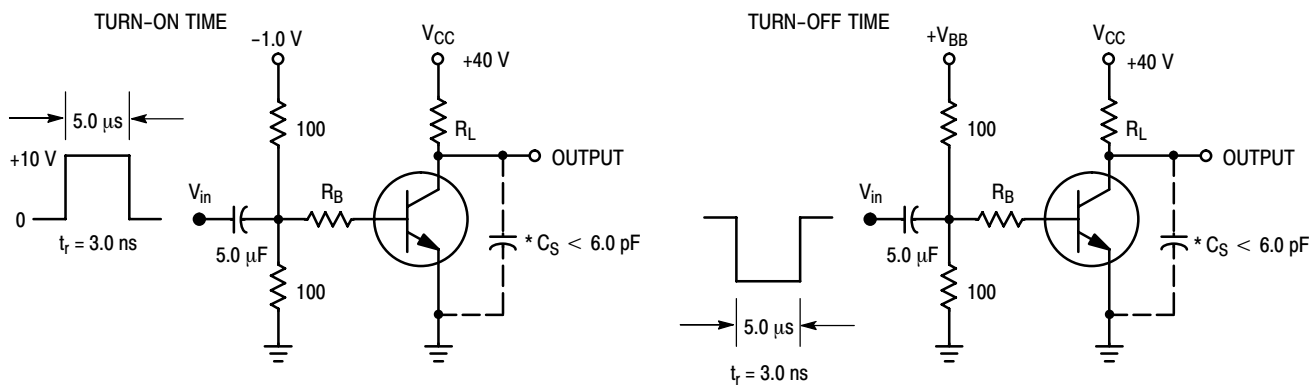

*Total Shunt Capacitance of Test Jig and Connectors For PNP Test Circuits, Reverse All Voltage Polarities

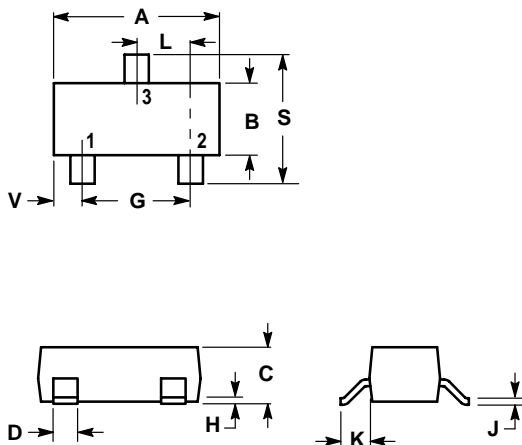
Figure 1. Switching Time Test Circuits
