2. General

The TLP171J photorelay consists of a photo MOSFET optically coupled to an infrared light emitting diode. It is housed in a 4-pin package with 2.54-mm lead pitch and 2.1-mm height. This photorelay requires 0.2 mA of LED current to turn it on. It is suitable for applications that need electrical power savings.










Fig. 11.1 Switching Time Test Circuit


