






Fig.1 Typical Capacitance vs. Drain-Source Voltage




Fig.2 Switching Characteristics




Fig.3 Dynamic Input Characteristics




Fig.4 Typical Transfer Characteristics




Fig.5 Static Drain-Source On-State Resistance vs. Gate-Source Voltage




Fig.6 Reverse Drain Current vs. Source-Drain Voltage




Fig.7 Static Drain-Source On-State Resistance vs. Drain current (I)




Fig.8 Static Drain-Source On-State Resistance vs. Drain current (II)




Fig.9 Static Drain-Source On-State Resistance vs. Drain current (III)




Fig.10 Static Drain-Source On-State Resistance vs. Drain current (IV)
